Brettenham House



Dear Neighbours,

It has been another progressive month on the Brettenham House Project. New lift shafts are being formed in Core 2 and 3, existing steelwork & concrete slabs are being demolished, installation of new steelwork and blockwork forming the new lift shafts for each level from basement to level 7, in total there are to be 7 lifts within the refurbishment build. Level 2 old office level is being stripped out and waste removal from site is ongoing. Did you know that McLaren have recycled 93.0% of Brettenham House demolition waste off site so far? We are also relocating the site offices and welfare to the South Elevation of the project and aim to have this completed by the end of March 2025, in time for the site Considerate Construction Scheme scoring visit on the 31st March 2025.


